OFFICIAL RULES AND PROCEDURES



DEADLINE TO ENTER EXTENDED TO DAY OF COMPETITION

2022 Awards Ceremony:
Friday, December 2, 2022 at 8:00 pm

ENTRY REGISTRATION/DROP-OFF

Friday, December 2, 2022 from 3:00 to 5:00 pm
Front building of Holiday Shopping Center (old Rite Aid)

ENTRY CATEGORIES

The following categories are open for entry:

- Adult Category – Individuals 18 years of age and older
- Teen Category – Individuals between 13 and 17 years of age
- Youth Category – Individuals between 9 and 12 years of age
- Child Category – Individuals between 5 and 8 years of age

JUDGING AND CRITERIA

Judging will be held on Friday, December 2 from 4:00 to 5:00 pm with an Awards Ceremony held at approximately 8:00 pm. Entries will be judged on 1) Overall appearance, 2) Originality & Creativity, 3) Difficulty, 4) Precision and 5) Consistency of Theme. Theme should be competitor's own and consistent throughout the entry. There is no overall theme for competition. Additionally, we will have attendees of the Palo Cedro Country Christmas vote on their favorites this year!

SIZE LIMITATIONS

Entry must be placed on a board base. Entries combined with a base must not be larger than 24 inches high, 24 inches wide, and 24 inches long. We suggest using $\frac{1}{2}$ " or $\frac{3}{4}$ " plywood as a base for your entry. Weight should not exceed 50 lbs.

MATERIALS AND CONSTRUCTION

Everything above the base of your entry must be constructed and composed completely of edible materials. The main structure of your entry must be constructed of at least 75% gingerbread, some of which should be exposed. Edible materials are not limited to candies and icings. Use of gum paste, fondant, pastillage, chocolate, modeling chocolate, royal icing, isomalt, cast sugar, gelatin, and pressed sugar is encouraged. Use of "Disco Dust", "Rainbow Dust", or hologram powder is permitted. Any entry of non-edible components will be automatically disqualified. No artificial display materials such as Styrofoam or interior lighting, are to be used in the construction or decoration of the entry. Candies must be unwrapped and free of any non-edible materials, for example: lollipop sticks. Non-edible materials such as paint and/or ribbon are approved (and encouraged) to decorate the outer edge of your plywood base only (not to exceed the length and/or width of the base).

Entries must be solely constructed by the individual entering the competition. Teen, Youth and Child competitors may be supervised, for safety precautions, by a parent, legal guardian, or classroom teacher.

IDENTIFICATION AND DESCRIPTION

Each entry's base will be clearly labeled with their PCCC assigned entry number (you will receive your number upon submission of your entry). Do not put your name in the title of your gingerbread entry or anywhere visible with your entry; doing so compromises the judging process and may disqualify you from the competition.

PLACING AND PRIZES

Grand Prize - \$1,000 prize check
Most Creative - \$500 prize check
Teen Category - \$300 prize check
Youth Category - \$200 prize check
Child Category - \$100 prize check
